- 1. The meeting was called to order at 7:00 p.m.
- 2. No Additions or Deletions to the Agenda.
- 3. 2022 Town Meeting Mailing of Ballots

Dave McShane would like to know what the Legislature has to say in the New Year before making a decision on whether the Town was willing to mail absentee ballots to all active voters. Brief discussion. No decision was made. The Board will discuss at the January 10th meeting.

- a) Emerald Ash Borer Dave talked to the Central Vermont Regional Planning Commission about an inventory of ash trees. They would do a variety of breakdowns. The Board discussed what to do. A lot of the trees are in Green Mountain Power's right-of-way. The inventory would not cost the Town.
- b) ARPA Funds The Board may send out a questionnaire for public input on what to spend the funds on.
- c) Town Plan Dave moved to approve the Town Plan for submittal to the Central Vermont Regional Planning Commission. The motion was seconded and passed with all ayes.

8. New Business

- a) The Listers submitted an Error & Omissions for a property owned by Peter Stickney. The correction is on current use. Dave moved to approve the Error & Omissions for Stickney property. The motion was seconded and passed with all ayes.
- b) Tammy Legacy mentioned there was a delay in getting the Selectboard vacancy notice posted on the website and Front Porch Forum. Due to the delay in posting, the Board will discuss the applicants at the next meeting which is on January 10th.
