- 1. The meeting was called to order at 7:15 p.m.
- 2. There were no additions or deletions to the agenda.
- 3. Re-Organization of the Board Dave moved to elect Jon Guiffre as Chair. The motion was seconded and passed with all ayes. The Board temporarily tabled the election of Vice-Chair.
- 4. Roxbury's 4th of July Celebration Mary Bouchard spoke to the Board about re-inventing the 4th of July Parade. Mary would like to hold the parade on July 3rd, which is a Sunday. When the requested responses come back from Michelle Acciavatti, the Board will discuss it at a Board meeting.

- a) Via email Nick Laskovski informed the Board about his concerns regarding a culvert on Shaw Road. The Board discussed Nick's concerns and possible remedies. Dave stated that Nick cannot put a ditch in the Town's right-of-way but could put a ditch in and a culvert across his driveway.

Dave will research the rules on what ARPA funds can be used for. Jon will contact TDS to discuss the Town's plans.

- b) The Board discussed the possibility of an audit on town accounts. Tammy will contact Sullivan, Powers & Co. to request some information on what an audit would cost. The Town currently has an annual review of the town accounts by Sullivan, Powers & Co.
