- Replace windows, per plans. After the bid has been awarded, the contractor is to work with the owner on picking windows utilizing the owner's allowance of \$4,000 for materials. Note: Do not include owner allowance in bid.
- · Install attic insulation/flooring and safety railing, per plans.
- Construct basement stairs.
- · Relocate attic stairs.
- Include the cost of constructing the bathroom(s) walls and roughing in the plumbing. After the bid has been awarded, the contractor is to work with the owner on picking fixtures and finishes utilizing the owner's allowance of \$15,000 for materials/installation. Note: Do not include owner allowance in bid.
- Include the cost of installing new doors, per plan. After the bid has been awarded, the contractor is to work with the owner in selecting the specific doors and hardware. Door and hardware is to be purchased utilizing the owner's allowance of \$10,000 for materials. Note: Do not include owner allowance in bid.
- Provide duplex outlets 8' O.C. along exterior walls.
- · Installation of 4 (duplex) ethernet wall jacks w/ Cat6 circuits (in conduit) "home run" back to future panel in NW corner of building.
